Investment philosophy

The portfolio is relatively focused, averaging around 25 to 45 holdings, while still being well diversified. The fund can invest in all market capitalizations, from large to small, making every attractive investment opportunity an investable option, regardless of company size.

This Growth At a Reasonable Price (GARP) approach offers investors the following advantages:


- · Management style yielding superior and steady returns

What is a strategy focused on Growth At a Reasonable Price (GARP)?

This strategy combines value and growth strategies to find financially solid companies with lasting, high growth potential trading at a discount relative to their intrinsic value. In comparison, a growth strategy identifies companies whose earnings are expected to increase faster than average. This can mean investing in emerging companies or expanding industries that have yet to yield a profit. This strategy puts little weight on the current trading price. **Comparison of the three strategies**

For investors, when it comes to exchange rate risk, the decision to hedge or not to hedge mainly depends on their objectives and their risk tolerance. The impact of exchange rate fluctuations on short-term returns may either be positive or negative. If an investor's investment decisions tend to be based on short-term performance, a currency hedge solution may help maintain discipline.

For managers, Fiera Capital's foreign currency hedging strategy consists in using future contracts on the U.S. dollar against which it wants to protect the portfolio. In doing so, the effect of exchange rate fluctuations is nullified.
