The Insurer reserves the right to change the transaction date without notice.

It should be noted that amounts invested in Canadian Equity Index and American Equity Index accounts will, without exception, be processed on the business day following their receipt.

Redemption and transfer fees: This investment may be redeemed or transferred at any time, subject to transfer and redemption fees, as applicable.
