# The La Capitale General Insurance Inc. THANKS Loyalty Program Contest

### 1. Contest Organizer

The THANKS contest is being held and organized by La Capitale General Insurance Inc. (La Capitale or the Contest Organizer).

#### 2. Contest Period

The contest will be held in Quebec from 12:00 a.m. ET on January 14, 2019 to 11:59 p.m. ET on December 31, 2019 (the "Contest Period").

## 3. Eligibility conditions

### 6. Specific prize conditions

- 6.1. The travel voucher (prize 1) can be redeemed for cash but cannot be refunded, transferred or assigned.
- 6.2. The gift cards (prize 2) cannot be redeemed for cash, refunded, transferred or assigned.

#### 7. Draw
