## The Beneva Power Stroke contest

### 1. CONTEST ORGANIZER

The *Beneva Power Stroke* contest is organized by Beneva Inc. ("Beneva" or the "Contest Organizer")

# 2. CONTEST PERIOD

The contest will be held in Quebec in two separate phases:

# 3. ELIGIBILITY CONDITIONS

To enter this contest, participants must:

- Be a resident of the province of Quebec.
- Be age 18 or over on July 17, 2023 for Phase 1 of the contest.
- Be age 18 or over on July 22, 2023 for Phase 2 of the contest.

#### 9. GENERAL CONDITIONS

The Contest Organizer and its affiliated companies may be doing business with one or more service provider(s) based outside of Quebec. It is therefore possible that some of your personal information held by the Contest Organizer may be stored outside of Quebec and governed by the laws of foreign countries or states. By completing these forms, participants tacitly accept such situation.
