

# CONTEST RULES

Win your company \$5,000 thanks to La Capitale

## 1. CONTEST ORGANIZER

The *Win your company \$5,000 thanks to La Capitale* contest is being organized by La Capitale General Insurance Inc. (La Capitale or the Contest Organizer)

## 2. CONTEST PERIOD

The contest will be held in Quebec from 12:00 a.m. ET on June 1, 2019, to 11:59 p.m. ET on December 31, 2019 (the Contest Period).

## 3. ELIGIBILITY CONDITIONS

To enter the contest, the participating company must:

- Have a place of business in the province of Quebec
- Be registered in the *Registraire des entreprises*
- Operate in one of the following business sectors:
  - **Retail:** food (groceries, convenience stores) real estate, clothing, decoration, hardware, eye care
  - **Service businesses:** garages (repair, gas stations, mechanical shops, car washes), driving schools, daycares, repair shops (shoemaking, sewing, electronics, household appliances)
  - **Professional services and non-profit organizations:** business offices, professional services and associations (lawyer, notary), non-profit organizations (seniors' clubs, associations), surveyors, veterinarians, consultants and self-employed workers
  - **Condominium syndicates:** divided co-ownership, undivided co-ownership
  - **Real estate owners:** apartment buildings, commercial buildings
  - **Health care and beauty salons:** hair salons, esthetics, medical care (physician, dermatologist, dietitian, audiologist, audioprosthodontist, podiatrist) therapy services, dental care

## 4. HOW TO ENTER

Participation in this contest is free, with no purchase necessary.

Participating eligible companies must satisfy the eligibility conditions and the other conditions set out in these contest rules.

Subject to the limitations contained herein, eligible companies may participate during the contest period in one of the following manners:

### A. At events in which La Capitale will participate

By completing a paper or electronic entry form that includes the renewal date of your commercial, property and/or commercial vehicle insurance contract.

### B. Online

By completing the electronic entry form which includes the renewal date of your commercial, property and/or commercial vehicle insurance contract.

**Limit:** One (1) entry per company, per product

### **C. At the time of telephone quote**

By requesting a telephone quote from La Capitale or one of its authorized representatives regarding a commercial insurance product (property or commercial vehicle).

**Limit:** Participants are entitled to one (1) entry per product for each quote regarding an insurance product mentioned above.

### **D. As a client of La Capitale**

Clients holding commercial, property or commercial vehicle insurance that is in force between May 1 and December 31, 2019 are automatically entered.

**Limit:** Each of the above-mentioned products entitles companies to one (1) entry per product.

## **5. PRIZE DETAILS**

Entering this contest gives the company a chance to win a cheque for \$5,000.

Maximum total value of prizes: \$5,000

## **6. DRAW**

**6.1.** The prize will be awarded by a random draw from all eligible entries. The draw will be held in the presence of an employee witness at 3:00 p.m. ET on February 1, 2020 at La Capitale's head office in Quebec City.

The odds of winning depend on the number of eligible entries received during the contest period.

**6.2.** A company can only receive one prize.

**6.3.** La Capitale reserves the right to disqualify companies or entries that are not in compliance with contest rules.

## **7. ENTRY RESTRICTIONS AND EXCLUSIONS**

**7.1.** The number of entries per company is limited, as described in Section 4 of these contest rules.

**7.2.** Companies owned by employees, mandataries, directors and representatives of La Capitale General Insurance and its affiliated companies, and companies of individuals residing at the same address, may not enter the contest.

**7.3.** Also excluded from entering the contest are companies belonging to affiliated agents and agencies, their employees and individuals residing at the same address.

## 8. GENERAL PROVISIONS

8.1. To be declared a winner, the company selected at random must:

- Be reached by telephone by the Contest Organizer, to discuss prize delivery arrangements within five (5) business days of the draw. To avoid being disqualified, be reached in no more than two (2) attempts and, if a voicemail message is left, return the Contest Organizer's call within five (5) days of the voicemail.
- Confirm that it meets the eligibility conditions and other requirements of these contest rules.
- Correctly and without assistance, answer a timed mathematical skill-testing question administered by telephone.

Failure to comply with any of the above conditions or to accept the prize will result in disqualification of the selected company. In such a case, a new draw will be conducted, in accordance with these contest rules, until an eligible company has been chosen and declared a winner. If no company is declared a winner within thirty (30) days following the original draw, the Contest Organizer will have the right to cancel the prize.

8.2. **Verification** Entries are subject to verification by the Contest Organizer. Any entry or entry attempt that is deemed to be fraudulent, illegible, incomplete, received late or otherwise not in compliance with contest rules will be rejected. In such a case, the company in question will not be entitled to an entry or a prize. The Contest Organizer's decision concerning any aspect of the contest, including but not limited to the eligibility or disqualification of entries or companies, will be final and without appeal, subject to a decision by the *Régie des alcools, des courses et des jeux du Québec* (RACJ) with regard to any matter under its jurisdiction.

8.3. **Disqualification** The Contest Organizer reserves the right to disqualify any company or cancel one or more entries from a company that enters this contest or tries to do so by any means contrary to these contest rules or which would be unfair to the other companies. This company may be referred to the appropriate judicial authorities. The Contest Organizer's decision regarding this aspect of the contest is final and without appeal.

8.4. **Prize acceptance** The prize must be accepted as described in these contest rules and is not, in any case, transferable in whole or in part to another company or person, unless otherwise indicated herein.

8.5. **Limitation of liability – Use of the prize** The prize winner releases the Contest Organizer, its advertising and promotional agencies and their employees, agents and representatives of all liability for any damage, inconvenience or loss resulting from his or her acceptance or use of the prize. Notice to entrants - Information disclosure outside of Canada** For the purposes of the online entry form, La Capitale and its affiliated companies may be doing business with one or more Internet service provider(s) based outside of Canada.
