

CONTEST RULES

The La Capitale General Insurance Inc. THANKS Loyalty Program Contest

1. Contest Organizer

The THANKS! contest is being held and organized by La Capitale General Insurance Inc. (La Capitale or the Contest Organizer).

2. Contest Period

The contest will be held in Quebec from 12:00 a.m. ET on January 1, 2020 to 11:59 p.m. ET on December 31, 2020 (the contest period).

3. Eligibility conditions

To enter this contest, participants must:

- Be a resident of the province of Quebec
- Be age 18 or over on or before December 31, 2020
- Have three or more recognized years of loyalty to La Capitale General Insurance on December 31, 2020.

4. How to enter

Participation in this contest is free, with no purchase necessary.

To enter the contest, individuals must satisfy the eligibility conditions and the other conditions set out in these contest rules.

Subject to the limitations contained herein, everyone with three or more years of loyalty recognized by the THANKS program of La Capitale General Insurance at the end of the Contest Period is automatically entered in the contest.

Limit: The number of entries per person varies based on the years of loyalty recognized by the THANKS Program, as follows:

6. Specific prize conditions

- 6.1. Laurier Du Vallon gift card (prize 1)
 - 6.1.1. The use of the gift card is subject to availability at the time of the reservation and other conditions imposed by the travel agency.
 - 6.1.2. The gift card can be used for any products offered by the Laurier Du Vallon agency.
 - 6.1.3. The gift card cannot be refunded, transferred, redeemed or assigned. It is valid at all Voyages Laurier Du Vallon offices.
 - 6.1.4. The gift card can be used and reused, until it has a \$0.00 balance.
- 6.2. The Esso gift cards (prize 2) cannot be refunded, transferred, redeemed or assigned.

7. Draw

- 7.1. The prize will be awarded by a random draw from the eligible entries in accordance with Section 4 of these contest rules. The draw will be held in the presence of an employee witness at 3 p.m. ET on February 4, 2021 at La Capitale's head office in Quebec City.
- 7.2. The odds of winning depend on the number of eligible entries determined in accordance with Section 4.
- 7.3. An individual can only receive one prize.
- 7.4. The draw will be held as described below.
- 7.5. The draw for the first prize will be made from among all the eligible entries, in accordance with Section 4. The winner of the first prize will be the first name that is drawn from among the eligible entries. Then, the draw for 20 gift cards will be held from among the remaining eligible entries.
- 7.6. La Capitale reserves the right to disqualify participants or entries that are not in compliance with contest rules.

8. Entry restrictions and exclusions

- 8.1. The number of entries per person is limited, as described in Section 4 of these contest rules.
- 8.2. Employees, mandataries, directors and representatives of La Capitale and its affiliated companies, and individuals residing at the same address, may not enter the contest.
- 8.3. Also excluded from entering the contest are affiliated agents and agencies, their employees and individuals residing at the same address.

9. General provisions

- 9.1. To be declared a winner, the participant selected at random must:
 - Be reached by telephone or email by the Contest Organizer, to discuss prize delivery arrangements within ten (10) business days of the draw. The Contest Organizer will make three (3) attempts by phone and one (1) by email. To avoid being disqualified, the selected participant must return the Contest Organizer's call within five (5) business days after the Contest Organizer's last attempt.
 - Confirm that he or she meets the eligibility conditions and other requirements of these contest rules.

If no participant is declared a winner within thirty (30) days following the original draw, the Contest Organizer will have the right to cancel the prize.

Any entry or entry attempt that is deemed to be fraudulent, illegible, incomplete, received late or otherwise not in compliance with contest rules will be rejected. - 9.3. **Disqualification.** The Contest Organizer reserves the right to disqualify any person or cancel one or more entries from a person who enters this contest or tries to do so by any means contrary to these contest rules or which would be unfair to the other participants. Such person may be referred to the appropriate judicial authorities. The Contest Organizer's decision regarding this aspect of the contest is final and without appeal.
- 9.4. **Prize acceptance.** The prize must be accepted as described in these contest rules and is not, in any case, transferable in whole or in part to another person, unless otherwise indicated herein.
- 9.5. **Limitation of liability – Use of the prize.** The prize winner releases the Contest Organizer, its advertising and promotional agencies and their employees, agents and representatives from any damage, inconvenience or loss resulting from his or her acceptance or use of the prize. In no case may the Contest Organizer, its subsidiaries, its advertising and promotional agencies, the suppliers of products or services related to this contest or its employees, agents and representatives be required to award more prizes or to award any prize other than in accordance with these contest rules.
- 9.9. **Authorization.** The prize winner authorizes the Contest Organizer and its representatives to, if required, use his or her name, photograph, image, voice, contact information, place of residence or any statement relating to the prize for advertising purposes, without any compensation.
- 9.10. **Participant.** For the purposes of these rules, the eligible participant is the person whose name appears on the liability waiver and declaration form, and it is to this person that the prize will be awarded, if selected and declared a winner.
