

CONTEST RULES

THANKS contest

1. Contest Organizer

The THANKS contest is being organized by La Capitale General Insurance Inc. (“La Capitale” or the “Contest Organizer”)

2. Contest period

The contest will be held in Quebec from 12:00 a.m. ET on January 1, 2021, to 11:59 p.m. ET on January 9, 2022 (the Contest Period).

3. Eligibility conditions

To enter this contest, participants must:

- Be a resident of the province of Quebec.
- Be age 18 or over before January 9, 2022.
- On January 9, 2022, hold an eligible insurance product from La Capitale General Insurance Inc.

4. How to enter

Participation in this contest is free, with no purchase necessary.

To enter the contest, individuals must satisfy the eligibility conditions and the other conditions set out in these contest rules.

Subject to the limitations contained herein, anyone with an eligible insurance product in force at the end of the Contest Period is automatically entered in the contest.

Limit: The number of entries per person does not increase because one person holds several eligible products. If a person holds several eligible products, only the product held for the longest duration will be considered for the contest. The number of entries per person varies based on the years of loyalty recognized by the THANKS Program, as follows:

Number of recognized years of loyalty	Number of entries
1 day to 2 years	1 entry
3 – 4 years	3 entries
5 – 9 years	5 entries
10 – 14 years	10 entries
15 – 19 years	15 entries
20 – 24 years	20 entries
25+ years	25 entries

5. Details of the prizes

6. Specific prize conditions

- a. Cheque for \$20,000 (prize 1).
This prize cannot be transferred or assigned.
- b. The Esso gift cards (prize 2) cannot be refunded, transferred, redeemed or assigned.

7. Draw

- a. The prize will be awarded by a random draw from the eligible entries in accordance with Section 4 of these contest rules. The draw will be held at 3:00 p.m. ET on February 10, 2022 in the presence of a La Capitale employee witness at the company's head office in Quebec City.
- b. The following insurance products are eligible for the draw: personal automobile insurance, home insurance for tenants, condominium owners, homeowners and non-resident owners, secondary residence, mobile home, ATV or side-by-side insurance, snowmobile insurance, motorcycle insurance, watercraft insurance, trailer, motorhome, stationary trailer, moped, utility trailer insurance or insurance for farm tractors.
- c. The odds of winning depend on the number of eligible entries determined in accordance with Section 4.
- d. An individual can only receive one prize.
- e. The draw will be held as described below.
 - The draw for the first prize will be made from among all eligible entries.
 - The winner of the first prize will be the first name that is drawn from among the eligible entries.
 - Then, the draw for 10 gift cards will be held from among the remaining eligible entries.
- f. La Capitale reserves the right to disqualify participants or entries that are not in compliance with contest rules.

8. Entry restrictions and exclusions

- a. The number of entries per person is limited, as described in Section 4 of these contest rules.
- b. Companies who hold one of the eligible products are excluded.
- c. Employees, mandataries, directors and representatives of La Capitale and its affiliated companies, and individuals residing at the same address, may not enter the contest.
- d. Also excluded from entering contests are representatives, affiliated agencies and agents, their employees and individuals residing at the same address.

9. General conditions

- a. To be declared a winner, the entrant selected at random must:
- Be reached by telephone or email by the Contest Organizer, to discuss prize delivery arrangements within ten (10) business days of the draw. The Contest Organizer will make three (3) attempts by phone and one (1) by email. To avoid being disqualified, the selected participant must return the Contest Organizer's call within five (5) business days after the Contest Organizer's last attempt.
 - Confirm that he or she meets the eligibility conditions and other requirements of these contest rules.
 - Correctly and without assistance, answer a timed mathematical skill-testing question administered by telephone.
 - Sign a liability waiver and declaration form, which will be forwarded by the Organizer. This form must be mailed to the Contest Organizer within five (5) business days following receipt. In such a case, a new draw will be conducted, in accordance with these contest rules, until an eligible entrant has been chosen and declared a winner. If no participant is declared a winner within thirty (30) days following the original draw, the Contest Organizer will have the right to cancel the prize.

- b. **Verification** – Entries are subject to verification by the Contest Organizer. Any entry or entry attempt that is deemed to be fraudulent, illegible, incomplete, received late or otherwise not in compliance with contest rules will be rejected. In such a case, the entrant in question will not be entitled to an entry or a prize. The Contest Organizer's decision concerning any aspect of the contest, including but not limited to the eligibility or disqualification of entries or entrants, will be final and without appeal, subject to a decision by the *Régie des alcools, des courses et des jeux du Québec* (RACJ) with regard to any matter under its jurisdiction.
- c. **Disqualification** – The Contest Organizer reserves the right to disqualify any person or cancel one or more entries from a person who enters this contest or tries to do so by any means contrary to these contest rules or which would be unfair to the other entrants. Such person may be referred to the appropriate judicial authorities. The Contest Organizer's decision regarding this aspect of the contest is final and without appeal.
- d. **Prize acceptance** – The prize must be accepted as described in these contest rules and is not, in any case, transferable in whole or in part to another person, unless otherwise indicated herein.
- e. **Limitation of liability – Use of the prize.** The prize winner releases the Contest Organizer, its advertising and promotional agencies and their employees, agents and representatives from any damage, inconvenience or loss resulting from his or her acceptance or use of the prize. Each entrant selected acknowledges that, as of his or her being informed of the prize delivery arrangements, the fulfilment of the obligations related to the prize becomes the entire and exclusive responsibility of the various service and product providers.

In no case may the Contest Organizer, its subsidiaries, its advertising and promotional agencies, the suppliers of products or services related to this contest or its employees, agents and representatives be required to award more prizes or to award any prize other than in accordance with these contest rules.
- i. **Authorization** – The prize winner authorizes the Contest Organizer and its representatives to, if required, use his or her name, photograph, image, voice, contact information, place of residence or any statement relating to the prize for advertising purposes, without any compensation.
- j. **Participant** – For the purposes of these rules, the eligible participant is the person whose name appears on the liability waiver and declaration form, and it is to this person that the prize will be awarded, if selected and declared a winner.
- k. **Prize limit** – In no case may the Contest Organizer be required to award more prizes or to award any prize other than in accordance with these contest rules.
