

# CONTEST RULES

## FAN MOMENTS

### 1. CONTEST ORGANIZER

The Fan Moments contest is organized by Beneva Inc. (“Beneva” or the “Contest Organizer”)

### 2. CONTEST PERIOD

The contest will be held in Quebec from 9:00 a.m. ET on August 16, 2023 to 11:59 p.m. ET on August 26, 2023 (“**Contest Period**”).

### 3. ELIGIBILITY CONDITIONS

To enter this contest, participants must:

- Be a resident of the province of Quebec.
- Be age 18 or over on August 28, 2023.

### 4. HOW TO ENTER

Participation in this contest is free, with no purchase necessary.

To enter the contest, participants must satisfy the eligibility conditions and the other conditions set out in these contest rules.

Subject to the limitations contained herein, there is one (1) way to enter during the Contest Period:

#### Online

By completing an electronic entry form on the Beneva website.

**Limit:** One (1) entry per person.

### 5. PRIZE DETAILS

Entering this contest gives you the chance to win one of the following prizes, and sharing it with a person of your choice (three winners in total):

Winner No. 1: One-on-one practice with an Alouettes quarterback.

The winner must be available on September 5 and 6, 2023.

Also includes:

- Two (2) Montreal Alouettes jerseys (approximate value of \$100).
- Two (2) Montreal Alouettes caps (approximate value of \$30).
- Five (5) tickets for the October 9, 2023 Alouettes game in the Beneva lounge (approximate value of \$1,718).

The approximate total value of the prize is \$2,608.

Winner No. 2: Training with the cheerleaders and attending an Alouettes game.

The winner must be available the week of September 10 (practice day to be confirmed) and on September 15, 2023 (Alouettes game day).

### 6. SPECIFIC PRIZE CONDITIONS

The prize cannot be redeemed for cash, transferred, assigned or exchanged.

### 7. DRAW

### 8. PARTICIPATION LIMITATIONS AND EXCLUSIONS

**8.1** The number of entries per person is limited, as described in section 4 of these contest rules.

**8.2.** Employees, officers, mandataries, directors, administrators and representatives of Beneva Inc. and its affiliated companies, and individuals residing at the same address, may not enter the contest.

**8.3** Also excluded from entering the contest are representatives, agents, firms and agencies attached to or affiliated with Beneva Inc. and its affiliated companies, and their employees and all other individuals living with them.

## 9. GENERAL CONDITIONS

**9.1** To be declared a winner, the entrant selected at random must:

- Reply to the email sent by the Contest Organizer to be informed of the terms and conditions for awarding their prize before Friday, September 1, 2023, at 11:59 p.m. The Contest Organizer will send two reminders: one by email on Wednesday, August 30, 2023, and one by telephone on Thursday, August 31, 2023, failing which the prize will be forfeited.
- Confirm that he or she meets the eligibility conditions and other requirements of these contest rules.
- Correctly and without assistance, answer a timed mathematical skill-testing question.
- Sign a liability waiver and declaration form, which will be forwarded by the Contest Organizer. This form must be sent to the Contest Organizer within thirty (30) business days following receipt. If no participant is declared a winner within thirty (30) days following the original draw, the Contest Organizer will have the right to cancel the prize.

**9.2 Verification** – Entries are subject to verification by the Contest Organizer. Any entry or entry attempt that is deemed to be fraudulent, illegible, incomplete, received late or otherwise not in compliance with these contest rules will be rejected. In such a case, the entrant in question will not be entitled to an entry or a prize. The Contest Organizer's decision concerning any aspect of the contest, including but not limited to the eligibility or disqualification of entries or entrants, will be final and without appeal, subject to a decision by the *Régie des alcools, des courses et des jeux du Québec* (RACJ) with regard to any matter under its jurisdiction.

**9.3 Disqualification** – The Contest Organizer reserves the right to disqualify any person or cancel one or more entries from a person who enters this contest or tries to do so by any means contrary to these contest rules or which would be unfair to the other entrants. Such person may be reported to the appropriate judicial authorities. The Contest Organizer's decision regarding this aspect of the contest is final and without appeal.

**9.4 Prize acceptance** – The prize must be accepted as described in these contest rules and is not, in any case, transferable in whole or in part to another person, unless otherwise indicated herein. The Fan Moments schedule cannot be modified and is based on the Alouettes' availability.

**9.5 Limitation of liability – Use of the prize.** The prize winner releases the Contest Organizer, its advertising and promotional agencies and their employees, agents and representatives from any damage, harm or loss resulting from his or her acceptance or use of the prize. Each participant selected acknowledges that, as of his or her being informed of the prize delivery arrangements, the fulfilment of the obligations related to the prize becomes the entire and exclusive responsibility of the various service and product providers.

**9.6 Limitation of liability – Operations.** The Contest Organizer, its advertising and

promotional agencies, its affiliated companies, their employees, agents and representatives are not liable for any faulty computer components, software or line of communication, or for the loss or absence of network communication capability, or for any faulty, incomplete, incomprehensible or erased computer or network transmissions that make it difficult or impossible to enter the contest.

**9.7 Limitation of liability – Registration.** The Contest Organizer, its advertising and promotional agencies, its affiliated companies, their employees, agents and representatives are not liable for any damage or loss that may be caused, directly or indirectly, in whole or in part, by the downloading of any web pages or software or by the transmission of any information concerning contest participation.

**9.8 Contest modification** – The Contest Organizer reserves the right, at its sole discretion, to cancel, terminate, modify or suspend this contest, in whole or in part, if there is any event or any human intervention that could corrupt or affect the administration, security, impartiality or conduct of the Contest as provided for in these Contest Rules, subject to RACJ approval, if required.

**9.9 Notice to entrants – Information disclosure outside of Canada.** The Contest Organizer and its affiliated companies may be doing business with one or more service provider(s) based outside of Quebec. It is therefore possible that some of the entrants' personal information held by the Contest Organizer may be stored outside of Quebec and governed by the laws of foreign countries or states. By completing such forms, participants tacitly accept such a situation.

**9.10 Authorization** – The prize winner authorizes the Contest Organizer and its representatives to, if required, use his or her name, photograph, image, voice, contact information, place of residence or any statement relating to the prize for advertising purposes, without any compensation.

**9.11 Participant** – For the purposes of these Contest Rules, the eligible participant is the person whose name appears on the entry and it is to this person that the prize will be awarded if selected and declared a winner.
